  - 4) The Citizen's Charter is written either in English, Filipino, or in the local dialect and published as an information material (e.g. booklet or brochure).
  - 5) The Citizen's Charter is uploaded in the agency's website and accessible to the public.
  - 6) The agency has undertaken self-assessment and reporting of improvements in its existing Citizen's Charter.
  - The Citizen's Charter shows the process improvements, specifically on the streamlining of procedures and shortened turnaround time, on the most availed frontline services:
